Workshop #1 - Young Dog:

This is focused on skills and drills for the young dog just approaching novice/open or sequencing. Dogs should have experience with all of the agility obstacles but need not be weaving. From 8:30am to 12:30pm. Cost is \$90 for a working spot. Limited to 8 dog/handler teams. Auditors welcome, \$40.

Workshop #2 - Masters Handling:

Work toward better handling at the Masters level. Dogs should be proficient at all obstacles. We'll cover challenging excellent courses and some international handling. From 1:00pm to 5pm. Cost is \$90 for a working spot. Limited to 8 dog/handler teams. Auditors welcome, \$40.

Andrea Samuels has achieved the highest honors in the sport with her homebred Starstruck Papillons. Below is just a short list of some of her accomplishments:

- 2005 and 2007 AKC/USA World Team Member with Chase. Placements at Tryouts with Chase and Sparkle
- 2 Time AKC National Agility Champion - in 2012 with Carly and in 2011 with Sparkle. Placed 3rd in 2013 with Chase. AKC Agility Nationals Finalist with 4 different dogs (Star 8 inch, Sparkle 8inch, Chase 12 and 8inch, Carly 8 inch)
- Invited multiple years to AKC Agility Invitationals with multiple dogs.
- Multiple MACH's on multiple dogs, over 20 MACH's to date.
- Tournament wins in GP, Steeplechase and DAM with limited trialing in USDAA. MAD titles on 3 different dogs
- Successful breeder of some of the top agility papillons competing in the United States
- Won breed championships and impressive conformation wins at all-breed shows, specialties and Westminster KC.
- Completed CDX and UD titles in obedience.
- Full time dog groomer dogs of various breeds and temperaments.
- Over 13 years experience riding and showing horses from small ponies to large warmbloods. Competed in Hunter, Jumper and Equitation classes.

Directions: Route I-495 (LIE) east/west to Exit 43N (South Oyster Bay Road) or Northern State Parkway east/west Exit 36N (South Oyster Bay Road). Take South Oyster Bay Road north. Cross Jericho Turnpike (Route 25). The road now is called Jackson Avenue. Continue straight across LIRR tracks into Syosset Village. Bear left at the 2nd light after the tracks (Shell station). Bear right at the five-way intersection onto Berry Hill Road. Pass Dairy Barn on the left and 7-Eleven on your right. First left onto Church Street. (Beney Funeral home on southwest corner). Turn right into the second driveway and drive to the rear parking area. (Note: 5 mph speed limit!)

We train in the rear building at the top of the stairs.
